Boom Spray	50mL	5L	For best results apply prior to periods of drought stress in a minimum of 400L/Ha of water.
Broadacre Injection	20 – 50mL	2 – 5L	Apply monthly or as required to ensure optimal efficiency is achieved during irrigation practices.
Positioning of soil-applied products	20 – 50mL	2 – 5L	To ensure proper placement of soil-applied products such as fertilisers, tank mix with Hydrolink Rapid and irrigate following application. Refer to Tank Mix Flexibility section before undertaking a tank mix.
