## Section 4 - First Aid Measures

### Section 6 - Accidental Release Measures

**Accidental release:** For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. # Section 7 - Handling and Storage

## Section 8 - Exposure Controls and Personal Protection

Exposure Limits: TWA (mg/m3) STEL (mg/m3) ADI (mg/Kg/day) NOEL (mg/Kg/day)

Exposure limits have not been set by SWA for any other ingredients in product. The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. There is a blanket limit of 10mg/m³ for dusts or mists when limits have not otherwise been established. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day.
